Setting Up Online Account Access

It's fast and easy! Using your laptop (not your phone or tablet), go to <https://myaccount.iconnect2invest.com>. Click on **Activate an Online Account** and simply follow the prompts from there. Once set up, you'll be able to take advantage of:

- » The ability to view your account statements and trade confirmations online
- » Portfolio tracking
- » Positions monitoring for held securities (equity positions updated with a 15-minute delayed quote)
- » Real-time quotes (100 free for signing up and 100 quotes per trade thereafter)
- » Free delayed quotes (unlimited)
